



MERCHANDISE VENDOR GUIDELINES

Date: Thursday, June 26, 2008

Time: 5:00 p.m. – 10:00 p.m.

Location: North Center Street & Adjacent Streets, and in Memorial Park (vendors will be set up in Memorial Park)

Space Size: 10' x 10'

Fee Per Space: \$50.00

Rules & Regulations:

- All vendors must submit 2 photos of your work with your application. Both photos will be returned to you. Those not accepted will have checks returned with photos. Please send a self addressed stamped envelope for return of photos.
- A 10' x 10' tent is strongly suggested. Exhibitor must provide tie downs and sandbags for tent.
- "Wheels & Wings" will take place rain or shine.
- **ONLY VENDORS THAT ARE CAR, TRUCK OR MOTORCYCLE RELATED WILL BE ACCEPTED.** We do not allow vendors to sell out of their vehicles. Vehicles must be removed from the event grounds by 4:30 p.m. on the day of the event. Trailers are accepted.
- Exhibitors are responsible for their own trash removal. Please leave the area as clean as you found it.
- Tables and chairs are not provided.
- Spaces may not be shared with any non-applicant.
- Only items listed on submitted application may be sold at the event. Vendor will be removed from the event if selling items that could be used as a weapon, silly string, etc.
- Vendor Fee is non-refundable. Failure to notify the "Wheels & Wings" committee of a cancellation in advance will affect future participation.
